  - ii) Fails or refuses to furnish the performance security, in accordance with clause \_\_\_\_\_ of conditions of Contract

We undertake to pay to the beneficiary up to the above amount upon receipt of his first written demand without the beneficiary having to substantiate his demand, provided that in his demand without the beneficiary will note that the amount claimed by him is due to him owing to the occurrence of one or both of the two conditions, specifying the occurred conditions of conditions.
